



## **Terms & Conditions**

Welcome to [www.nseacademy.com/ncfmlms/] (“NCFM PRO”, hereinafter referred as “LMS”). This LMS is owned and operated by **NAL Academy Limited** (“NAL Academy”, “we”, “our”, or “us”), a company incorporated under the Companies Act, 2013, having its registered office at 202, Ashok Compound, Lal Bahadur Shastri Marg, Ghatkopar West, Mumbai, Maharashtra – 400086.

NAL Academy offers a range of educational programs and certifications in financial markets, technology, and related domains, in collaboration with leading academic institutions and industry partners (“Services”). These Terms & Conditions (“Terms”) govern your access to and use of the LMS and Services. By accessing or using the LMS, you agree to be bound by these Terms.

These Terms of Use constitute the agreement between you and the NAL Academy in relation to your use of the LMS and/or the Services. By using this LMS and/or the Services you indicate your acknowledgment and acceptance of these Terms of Use. These Terms of Use will apply to all users on the LMS and to visitors’, i.e., users who simply browse the LMS. ## **ELIGIBILITY**

## **USER ACCESS, CONSENT TO USE OF DATA**

In order to register with the LMS, you will have to provide your name, email id, phone/mobile number, address, education, graduation year and graduation percentile, professional experience.

You agree to: (a) provide true, accurate, current and complete information about yourself as required in the registration form available on the LMS (“**Registration Data**”) and (b) maintain and promptly update the Registration Data to keep it true, accurate, current and complete.
